DECISION NO/2018 OF THE EU-UKRAINE ASSOCIATION COMMITTEE IN TRADE CONFIGURATION

on the establishment of the list of arbitrators referred to in Article 323(1) of the Association Agreement between the European Union and the European Atomic Energy Community and their Member States, of the one part, and Ukraine, of the other part

THE ASSOCIATION COMMITTEE IN TRADE CONFIGURATION,

Having regard to the Association Agreement between the European Union and the European Atomic Energy Community and their Member States, of the one part, and Ukraine, of the other part¹, signed in Brussels on 27 June 2014 ('the Agreement'), and in particular Articles 323(1) and 465(3) thereof,

Whereas:

- (1) In accordance with Article 323(1) of the Agreement, the Association Committee in Trade configuration shall, not later than six months from the entry into force of the Agreement, establish the list of individuals who are willing and able to serve as arbitrators.
- (2) The Union has proposed five candidate arbitrators. Ukraine has proposed four individuals willing and able to serve as arbitrators. Ukraine and the Union have agreed on five third-country nationals who may serve as chairpersons to an arbitration panel.
- (3) To avoid further delays in the establishment of the list of individuals willing and able to serve as arbitrators and thereby ensure the proper functioning of the Agreement and notably of Chapter 14 of Title IV thereof, the Association Committee in Trade configuration shall approve that list on the basis of the submitted proposals.
- (4) Ukraine shall propose a fifth candidate to the Association Committee in Trade configuration as soon as possible.

HAS ADOPTED THIS DECISION:

Article 1

- 1. The list of individuals who are willing and able to serve as arbitrators pusuant to Article 323(1) of the Association Agreement between the European Union and the European Atomic Energy Community and their Member States, of the one part, and Ukraine, of the other part, is established as Annex to this Decision.
- 2. Ukraine shall propose to the Association Committee in Trade configuration as soon as possible a fifth candidate who is willing and able to serve as arbitrator.

Article 2

This Decision shall enter into force on the day of its adoption
