Delegations took note of the presentation by Europol on its EU internet referral unit (IRU). Europol has presented to the Commission a proposal to establish an EU Referral Platform.

5. Interpol: Presentation on DTECH light

Presentation by INTERPOL

Delegations took note of the presentation by Interpol. This project intends to detect, extract and analyse digital terrorist content, identify and locate suspects related to terrorism and collaborate with regional organisations. This data is shared through INTERPOL i-24/7 by Member Countries and regional organisations. The output will be operational (identification and alerts) and strategic (trend reports and library).

8. Information on counter-terrorism activities

The Commission, the EU External Action Service, Europol and the EU Counter Terrorism Coordinator shared information on recently held and upcoming meetings and events. The Commission informed about the recent joint meeting of the CBRN Security Advisory Group and the Standing Committee on Precursors and the incoming High Level RAN (Radicalisation Awareness Network) conference to take place in Luxembourg on 11 October 2018 as well as an upcoming meetings about protection of public spaces. The Commission encouraged Member Sates which had not yet done so to implement the CT Directive (deadline for transposition: 8 September 2018). Europol informed about an incoming meeting of Heads of CT units on 16 November 2018. EEAS informed about the incoming CT political dialogues with India, Israel, Pakistan and Tunisia. A technical meeting with Russia was scheduled for 15-16 October 2018.
