	 Approval of a reply

- 1. The Common Understanding on delegated acts establishes, in paragraph 14, that "by October of the year preceding the elections to the European parliament, the three institutions shall agree on an arrangement for the notification of delegated acts during the election recess."
- 2. On 5 September 2018, the Commission submitted to the European Parliament and to the Council a draft agreement on the European election recess period in 2019 for the transmission of delegated acts and draft measures adopted under the regulatory procedure with scrutiny².
- 3. At its meeting on 12 October 2018, the General affairs Working Group examined the draft agreement and agreed to forward the text to Coreper for endorsement.
