### THE COUNCIL OF THE EUROPEAN UNION.

Having regard to Council Regulation (EEC) No 337/75 of 10 February 1975 establishing the European Centre for the Development of Vocational Training, and in particular Article 4 thereof <sup>1</sup>,

Having regard to the nomination submitted by the Commission,

#### Whereas:

- (1) By its Decision of 16 July 2018<sup>2</sup> and Corrigendum to Council Decision of 16 July 2018<sup>3</sup>, the Council appointed the members of the Governing Board of the European Centre for the Development of Vocational Training for the period from 18 September 2018 to 17 September 2021.
- (2) A member's seat is available for Slovakia on the Governing Board of the Centre in the category of the representatives of the employees' organisations as a result of the resignation of Ms Petronela KURAJOVÁ.
- (3) The members of the Governing Board of the aforementioned Centre should be appointed for the remainder of the current term of office, which expires on 17 September 2021.
