Subject:	Prüm Decisions - IMPLEMENTING DECISION on the launch of automated data exchange with regard to dactyloscopic data in Croatia

1. The Working Party on Information Exchange and Data Protection (DAPIX) approved at its meeting on **25 June 2018** the evaluation visit report on **dactyloscopic data** exchange for **Croatia** (9087/18 DAPIX 142 CRIMORG 69 ENFOPOL 248 ENFOCUSTOM 111 JAI 503) as well as the overall report (9089/18 JAI 440 DAPIX 143 CRIMORG 70 ENFOPOL 249 ENFOCUSTOM 103) based on the questionnaire, an evaluation visit and a pilot run.
2. At the DAPIX meeting of **25 June 2018**, it was acknowledged that each Member State bound by Decision 2008/615/JHA agrees that the conditions are fulfilled for the Council to conclude that for the purposes of automated data exchange with regard to **dactyloscopic data, Croatia** has fully implemented the general provisions on data protection of Chapter 6 of Decision 2008/615/JHA.

3. Consequently, the Council adopted on **16 July 2018** the draft Council Conclusions on the implementation of the general provisions on data protection of Chapter 6 of Council Decision 2008/615/JHA concerning **Croatia** with regard to automated exchange of **dactyloscopic data** (11225/18 DAPIX 236 CRIMORG 101 ENFOPOL 386 ENFOCUSTOM 158 JAI 780).
4. As required by the applicable Treaty provisions, the Council decided on **3 August 2018** to consult the European Parliament on the draft Council Implementing Decision on the launch of automated data exchange with regard to **dactyloscopic data in Croatia**, as finalised by the Legal/Linguistic Experts and set out in 11284/18 DAPIX 244 CRIMORG 108 ENFOPOL 394 ENFOCUSTOM 165 JAI 792.
5. The European Parliament gave its opinion on **24 October 2018**.
6. *On this basis, COREPER is requested*
 - *to submit the overall report* (9089/18 JAI 440 DAPIX 143 CRIMORG 70 ENFOPOL 249 ENFOCUSTOM 103) *to the Council, and*
 - *to invite the Council to adopt as an "A" item on its agenda the draft Council Implementing Decision on the launch of automated data exchange with regard to **dactyloscopic data in Croatia*** (11284/18 DAPIX 244 CRIMORG 108 ENFOPOL 394 ENFOCUSTOM 165 JAI 792).
