1. On 8 September 2003 a vast majority of delegations reached agreement on an updated list.
2. At its meeting of 8 September 2003, the Foreign Relations Counsellors Working Group reached agreement on a draft Council Common Position and a draft Council Decision in which the list referred to above should be inserted.

## RESTREINT UE

3. The Committee of Permanent Representatives is therefore requested to:
- reach agreement on the draft Council Common Position, including its Annex, and on the draft Council Decision, including its Article 1;
  - approve the use of the written procedure for adoption of the Council Common Position updating Common Position 2001/931/CFSP on the application of specific measures to combat terrorism and repealing Common Position 2003/482/CFSP and of the Council Decision implementing Article 2(3) of Regulation (EC) N°2580/2001 on specific restrictive measures directed against certain persons and entities with a view to combating terrorism and repealing Decision 2003/480/EC, to be launched as soon as the Common Position and the Council Decision are finalised by the legal/linguistic experts (doc. 12234/03 PESC 489 RELEX 325 FIN 368 COTER 43 OC 548 LIMITE, including its Annex, and doc. 12235/03 PESC 490 RELEX 326 FIN 369 COTER 44 OC 549 LIMITE, including its Article 1).
  - agree to publish the Council Common Position and the Council Decision in the Official Journal.
