Subject:	Eurojust's intention to enter into negotiations with a view to concluding a cooperation agreement with Frontex

- 1. By letter of 8 November 2018 (see the <u>Annex</u>), the President of Eurojust informed the Council about Eurojust's intention to enter into negotiations with a view to concluding a cooperation agreement with Frontex, in application of point (c) of Article 26(1) of Council Decision 2002/187/JHA of 28 February 2002 setting up Eurojust, as last amended by Council Decision 2009/426/JHA of 16 December 2008.
- 2. In accordance with Article 26(2) of that Decision, following such information (notification) *'the Council may draw any conclusions it deems appropriate'*.
- 3. In this light, the said letter was put up for discussion with the Member States at the JAIEX meeting on 3 December 2018. No comments were presented by Member States.
- 4. Subject to confirmation by Coreper, the Council is invited to take note of Eurojust's intention to enter into negotiations with a view to concluding a cooperation agreement with Frontex.
