The Slovak Republic wishes to replace the declarations set out in 8718/05 by the following:

**Declarations by the Slovak Republic
on Council Framework Decision 2002/584/JHA of 13 June 2002 on the European arrest
warrant and the surrender procedures between Member States**

Re Art. 6(3)

'Where the Slovak Republic is the issuing Member State, the authority competent to issue a European arrest warrant is any Slovak court.

Where the Slovak Republic is the executing Member State, the competent authority is the Regional Prosecutor's Office in whose jurisdiction the requested person has been detained or otherwise subjected to restrictions on his or her personal freedom.

However, the Slovak Ministry of Justice of the Slovak Republic will provide the necessary assistance to the judicial authorities of the issuing Member State and to the executing judicial authorities.'

Re Art. 8(2)

'European arrest warrants addressed to the Slovak judicial authorities must be accompanied by a translation into Slovak. The Slovak Republic will accept a European arrest warrant under this legal act in relation to the Czech Republic in Czech, in relation to the Republic of Poland in Polish and in relation to the Republic of Austria in German.'

Re Art. 25(2)

'Requests for consent to transit through the territory of the Slovak Republic are to be sent to the Ministry of Justice:

The request must contain:

- a) The first name, surname, date of birth, place of residence and nationality of the person,
- b) a reference to the relevant European arrest warrant,
- c) and the legal classification of the offence.

The European arrest warrant must also be attached to the request.'
