THE COUNCIL OF THE EUROPEAN UNION,

Having regard to the Treaty on the Functioning of the European Union,

Having regard to Regulation (EU) No 492/2011 of the European Parliament and of the Council of 5 April 2011 on freedom of movement for workers within the Union<sup>1</sup>, and in particular Articles 23 and 24 thereof,

Having regard to the lists of candidates submitted to the Council by the Governments of the Member States,

Whereas:

 By its Decisions of 28 September 2018<sup>2</sup>, of 15 October 2018<sup>3</sup> and of 19 November 2018<sup>4</sup> the Council appointed the members and alternate members of the Advisory Committee on Freedom of Movement for Workers ("Committee") for the period from 25 September 2018 to 24 September 2020.
