The SCA took note of delegations' views on the Presidency's questions proposed in document WK 672/19. On the basis of that exchange of views, the Presidency will reflect on how to steer the debate at the "Agriculture and Fisheries" Council of 28 January 2019.

On Article 40 of the Horizontal Regulation, the Presidency noted broad support within the SCA for the Presidency proposal to remove the "brackets" from that Article and would report it to the Chair of the Ad Hoc Working Party on the MFF for decision.

As regards the CMO Regulation and wine varieties, the SCA endorsed the Presidency's questions for the Council's policy debate on 28 January.
