Subject:	Management Board of the European Institute for Gender Equality: Appointment of Ms Ida Sophia Charlotta ÖSTERBORG, alternate member for Sweden, in place of Ms Annika MANSNÉRUS, who has resigned

- 1. The General Secretariat of the Council has been informed of the resignation of Ms Annika MANSNÉRUS as alternate member of the Management Board of the European Institute for Gender Equality in the government representatives category (for Sweden).
- 2. Article 10 of Regulation (EC) No 1922/2006 of 20 December 2006¹ provides, inter alia, that the Council should appoint 18 members, as well as alternates, of the Management Board of the European Institute for Gender Equality for a period of three years.

Having regard to Regulation (EC) No 1922/2006 of 20 December 2006 establishing the European Institute for Gender Equality², and in particular Article 10 thereof,

Whereas:

- (1) By its Decision of 26 May 2016³ the Council appointed the members and alternate members of the Management Board of the European Institute for Gender Equality, for the period ending on 31 May 2019.
- (2) An alternate member's seat in the government representatives category has fallen vacant as a result of the resignation of Ms Annika MANSNÉRUS.
- (3) The Government of Sweden has submitted a nomination for the vacant seat,
