Government decision

In accordance with Article 305 of the Treaty on the Functioning of the European Union, the Swedish government has decided to nominate Katrin Stjernfeldt Jammeh (Social Democrats) of Malmö municipal council and Agneta Granström (Green Party) of Norrbotten county council as members of the European Committee of the Regions until 25 January 2020 (see annex).

Background

Heléne Fritzon (Social Democrats) and Joakim Larsson (Green Party) have resigned from their positions as members of the European Committee of the Regions. The Swedish Association of Local Authorities and Regions has proposed that Katrin Stjernfeldt Jammeh be nominated as a member in place of Heléne Fritzon, and Agneta Granström in place of Joakim Larsson.
