

## Statements to the legislative "B" items set out in 14772/18

Regulation on the European Solidarity Corps (ESC) 2021 to 2027 **Ad "B" item 3**:

#### STATEMENT BY GREECE

"Greece expresses its serious concerns on the proposed integration of the European Voluntary Humanitarian Aid Corps to the European Solidarity Corps, in particular due to the lack of opportunity for all European citizens, regardless of age, to participate actively in the EU humanitarian response operations in third countries. Greece also considers that the European Voluntary Humanitarian Aid Corps, provided explicitly by the Treaty on the Functioning of the EU (article 214, para 5), should not be set aside by a new Regulation and thus lose its own identity."

#### STATEMENT BY FRANCE, GREECE, CYPRUS, BELGIUM

"France, Greece, Cyprus and Belgium are expressing their concerns with regard to the use of delegated acts in the case of the evaluation indicators for the Erasmus+ programme (foreseen in articles 20 and 30) and for the European Solidarity Corps (foreseen in articles 19 and 29).

Evaluation indicators define the parameters that are estimated crucial for the implementation of the programs, offering the necessary policy guidelines to those who are vested with the responsibility to implement them. Consequently, they have a political character and delegated acts are not the appropriate procedure to elaborate and select them. The procedure of delegated acts does not allow an in-depth debate and a co-elaboration of such indicators to take place.

## **Ad "B" item 7:** Regulation on Erasmus

#### STATEMENT BY FRANCE, GREECE, CYPRUS, BELGIUM

"France, Greece, Cyprus and Belgium are expressing their concerns with regard to the use of delegated acts in the case of the evaluation indicators for the Erasmus+ program (foreseen in articles 20 and 30) and for the European Solidarity Corps (foreseen in articles 19 and 29).

Evaluation indicators define the parameters that are estimated crucial for the implementation of the programs, offering the necessary policy guidelines to those who are vested with the responsibility to implement them. Consequently, they have a political character and delegated acts are not the appropriate procedure to elaborate and select them. The procedure of delegated acts does not allow an in-depth debate and a co-elaboration of such indicators to take place.

Therefore France, Greece, Cyprus and Belgium regret the choice made in the above articles, which shall not constitute a precedent for the future."

# STATEMENT BY THE CZECH REPUBLIC, GERMANY, ESTONIA, GREECE, SPAIN, CROATIA, ITALY, LITHUANIA, THE NETHERLANDS, PORTUGAL, SLOVAKIA AND SLOVENIA

"The Czech Republic, Germany, Estonia, Greece, Spain, Croatia, Italy, Lithuania, the Netherlands, Portugal, Slovakia and Slovenia welcome the Austrian Presidency compromise proposal on the Erasmus+ programme 2021-2027 which will boost learning mobility within and beyond Europe as well as facilitate transnational institutional cooperation in education, training, youth and sport.

The Czech Republic, Germany, Estonia, Greece, Spain, Croatia, Italy, Lithuania, the Netherlands, Portugal, Slovakia and Slovenia wish to underline that support through the Erasmus+ programme should normally be granted following a call for proposals and a thorough evaluation process of applications. Direct support to institutions through the programme, such as the Jean Monnet actions, can only be justified when institutions are unique and pursue activities of a common interest to the Union.

With regard to Jean Monnet actions referred to in article 7 of the programme proposal, the Czech Republic, Germany, Estonia, Greece, Spain, Croatia, Italy, Lithuania, the Netherlands, Portugal, Slovakia and Slovenia support the goals to 1) stimulate teaching, learning and research in European integration matters as well as to 2) contribute to the development of excellence in European integration studies. To this end the Czech Republic, Germany, Estonia, Greece, Spain, Croatia, Italy, Lithuania, the Netherlands, Portugal, Slovakia and Slovenia embrace the monitoring and evaluation mentioned in recital 31 with regard to the development of the institutions which will be funded under article 7c of the proposal.

The Czech Republic, Germany, Estonia, Greece, Spain, Croatia, Italy, Lithuania, the Netherlands, Portugal, Slovakia and Slovenia urge the European Commission to:

- ensure that the evaluation of the institutions funded under article 7c and referred to in recital 31, will be completed by the time of the interim evaluation mentioned in article 21.2;
- carry out a mapping exercise with the view to examining the existence of institutions in the Member States pursuing an aim of European interest and European integration studies;
- develop on the basis of the evaluation and the mapping exercise funding criteria until 2027 with the aim of facilitating open and transparent selection procedures for such institutional funding in a possible successor programme from 2028 onwards."

#### STATEMENT BY PORTUGAL, GREECE AND FRANCE

"Portugal, Greece and France welcome the Austrian Presidency compromise proposal on the Erasmus+ programme 2021-2027, which will support the educational, professional and personal development of people in education, training, youth and sport, fostering learning mobility and transnational institutional cooperation, in Europe and beyond, thereby contributing to sustainable growth, jobs and social cohesion and to strengthening European identity and citizenship.

Portugal, Greece and France warmly welcome and wishes to **underline the inclusive approach of the Erasmus+ programme for 2021-2027**, one of the greater added value of the future programme for education, training, youth and sport.

Portugal, Greece and France consider that **the new programme should be effectively inclusive** and that excluding adult learners from Key Action 1 (Learning mobility activity), the unique learner group from education and training sector excluded from KA1, will send a negative signal, including at political level.

This is why Portugal, Greece and France express their concerns related to the fact that the draft regulation on the future programme does not include a reference to the learning mobility of adult learners in Key Action 1, in article 4.

Portugal, Greece and France recall that, under the current Erasmus+ programme, pupils from school education are not included in Key Action 1, and that, within the future Erasmus+ programme for 2021-2027, the pupils learning mobility will be funded under Key Action 1, as specifically stated in article 4.

Therefore, Portugal, Greece and France **urge the European Commission to**:

- ensure that, under the future programme for education, training, youth and sport (2021-2027), efforts will be made to promote the adult learning mobility;
- carry out a study to examine the impacts of adult learning mobility if funded under Key Action 1 (both financial and administrative), with the view to a potential funding of learning mobility for all adults within a possible successor programme from 2028 onwards."

#### Statements to the legislative "A" items set out in 14478/18

**Ad "A" item 1:** Regulation on medicated feed

Adoption of the legislative act

#### STATEMENT BY AUSTRIA

"With a view to the objective of the Regulation, which is to achieve a high degree of protection of human health, Austria would like to draw attention to the following points:

It should only be possible to use veterinary medicinal products via the feed channel when there is a specific need (i.e. in the case of sickness).

In the interests of subsidiarity in accordance with the new Regulation on the manufacture, placing on the market and use of medicated feed, it should be possible to maintain established national control systems for the use of medicated feed directly on the farm, as is currently practised in Austria by registered on-farm mixers.

In order to take account of the special needs of small-scale agriculture, primarily involving family farms, the requirements for the manufacture of medicated feed must be implemented in a way that is feasible and practical for on-farm mixers. The manufacture and administration of medicated feed by trained farmers under the supervision of a veterinarian constitutes a well-established practice in Austria which minimises many risks, as the medicinal products are used in the place and in the quantity in which they are absolutely needed."

**Ad "A" item 2:** Regulation on veterinary medicinal products

Adoption of the legislative act

#### STATEMENT BY THE COMMISSION

"The new EU Regulation on veterinary medicinal products requires Member States to collect and report data on sales and use of antimicrobials used in animals. The Commission considers this information essential to identify possible risk factors for development and spread of antimicrobial resistance (AMR), monitor trends in antimicrobial consumption, target relevant policy measures and assess their implementation. Although the implementation of this legal requirement is foreseen through a gradual (stepwise) approach, it may require substantial input in terms of administrative, human and financial resources.

The European One Health Action Plan against AMR recognises that in order to deliver long-lasting results and create the necessary impetus, it is important that the EU legislation related to AMR (including, inter alia, on the use of veterinary medicines) is adequately implemented. In this context, the Commission has committed in that Action Plan to engage in supporting Member States in the implementation of EU rules, including by providing technical support through the Structural Reform Support Service (SRSS) for designing and implementing policies against AMR.

Furthermore, the Commission will explore the possibilities for supporting this data collection in Member States in line with its proposals made in the context of the future EU Multiannual Financial Framework."

#### STATEMENT BY THE CZECH REPUBLIC

"The Czech Republic can agree that the update of the existing Directive 2001/82/EC would be beneficial in the case of <u>full and reasonable adherence to the objectives and principles</u> as declared by the European Commission prior the beginning of negotiations of the draft regulation on veterinary medicinal products.

The Czech Republic also strongly supports the objective to contain the risks related to antimicrobial resistance. However, the failure of the new legislation to enforce compliance with the EU standards, inter alia, with respect to restricted conditions for use of antimicrobials, by the 3<sup>rd</sup> countries, weakens significantly the EU political message with respect to commitments to fight against the antimicrobial resistance and in the same time, renders the EU producers uncompetitive with their 3<sup>rd</sup> countries counterparts. In addition, the required room for flexibility for the Member States to ensure availability of suitable alternatives to antimicrobials in particular on the small markets, and risks related to future availability of old, legacy, veterinary medicinal products, present another key issues related to the new regulation.

The proposal according to the Czech Republic opinion will increase administrative and associated financial burdens both for the public budgets and for private enterprises. It is becoming apparent that the implementation of the regulation will be more costly than originally expected. This new regulation will also decrease the flexibility and - in the consequence – the innovation, what can cause lack of availability of the veterinary medicinal product on the Czech market.

The text also contains apparent mistakes that can have an impact on the safety of consumer. The Czech Republic regrets to express that via the approval of this regulation we miss the opportunity to meet the principles as were originally declared and intended to be reached.

The Czech Republic therefore keeps the position from the COREPER after the trilogue (June 2018) and abstains from the voting."

#### STATEMENT BY GERMANY

"Germany would like to comment as follows on Articles 73 to 81 in the version set out in the present document, PE-CONS 45/18:

The final document PE-CONS 45/18 on the proposal for a Regulation of the European Parliament and of the Council on veterinary medicinal products represents an essentially balanced overall outcome, in which agreement was reached on many important points. However, Germany is concerned that in pharmacovigilance for veterinary medicinal products the emphasis is placed on signal management performed by the marketing authorisation holder, and the provisions currently in force are not to be maintained. This applies in particular to

- the discontinuation of the periodic safety update reports,
- the extension of the period allowed for reporting serious undesirable effects of the medicinal products, and
- the lack of differentiation as regards the degree of seriousness of undesirable effects of the medicinal products.

Since, however, the discussions led to improvements being achieved overall, the remaining concerns from Germany's point of view do not prevent us from giving our consent to the final compromise text."

# Ad "A" item 3: Regulation amending Regulation (EC) No 726/2004 as part of the

**Veterinary Medicines Package** *Adoption of the legislative act* 

#### STATEMENT BY THE COMMISSION

"The Commission recalls its position that when adapting existing Commission empowerments to Article 290 and 291 TFEU it is not an appropriate legislative technique to provide for transitional provisions that would state that Commission acts adopted previously under those empowerments will continue to apply unless and until repealed. In the Commission's view such provisions state the obvious and would not be coherent with other legislative acts and are liable to induce legal uncertainty at a broader level.

The Commission regrets that only part of the existing regulatory procedure with scrutiny empowerments in Directive 2001/83 and Regulation 1901/2006 will be aligned in this instrument, while the rest of the empowerments remain to be aligned in the context of the negotiations on the Omnibus alignment proposal (COM(2016) 799). In the Commission's view the full alignment should have taken place in one of the two instruments."
