The Council regrets the deficiencies found by the Court in the Agency's accounting environment. It calls on the Agency to take appropriate actions mainly to ensure the accounting officer's independence.

The Council welcomes the improvements in the financial and performance checks for grants carried out by the Agency, which led to a reduction in the final grant amount paid to one of the European Topic Centres (ETC) for the implementation of its 2016 action plan.

The Council, whilst taking note of the Agency's reply and actions taken, regrets the weaknesses found by the Court in the Agency's procurement procedures and calls on the Agency to take appropriate actions in order to ensure the effectiveness of the process, an appropriate assessment of bidders, as well as the full implementation without unjustified delay of electronic public procurement.

The Council encourages the Agency to ensure proper transparency and publicity of its vacancy notices, while avoiding unjustified costs.

The Council agrees with the Court's observation, that timely pre-financing payments by the Commission are a requirement to allow the implementation of delegation agreements. Therefore, the Council calls on the Agency to observe this requirement in the future and it invites the Commission to enable necessary changes to delegation agreements in a timely manner.

The Council regrets the deficiencies found by the Court in the Agency's accounting environment. It calls on the Agency to take appropriate actions mainly to ensure the accounting officer's independence, as well as to remedy any unjustified delays in the re-validation of its accounting system.

The Council welcomes the efforts made by the Agency to implement an Action Plan established with a view to address the Court's recommendations from previous years to remedy the weaknesses found by the Court in the Agency's information, communication and technology management control. The Council encourages the Agency to promptly assess the measures taken.

Nevertheless, some observations need to be made.

The Council regrets the weaknesses found by the Court in the Agency's accounting environment. It calls on the Agency to take appropriate actions mainly to ensure the accounting officer's independence.

While acknowledging the Court's changes in its reporting approach on carryovers, as well as the multiannual nature of many of the Agency's projects, the Council regrets that, again, high level of commitment appropriations was carried over to 2018. The Council urges the Agency to continue improving its financial programming and monitoring of budget implementation in order to reduce the unjustified level of commitments carried over and the amounts cancelled at the end of the following year to the strict minimum, in line with the budgetary principle of annuality.

The Council calls on the Agency to ensure the full implementation without unjustified delay of electronic public procurement.

While acknowledging the unprecedented expansion of tasks and activities of the Office since 2016, mirrored by a budget increase and a substantial rise in the number of procurement procedures and payments in the context of the migration crisis, the Council is deeply concerned that the payments underlying the accounts are materially affected by error due to systematic instances of non-compliance, mainly related to public procurement and recruitment procedures.

The Council regrets the numerous weaknesses found by the Court in different areas of the Office's activities. The Council, therefore, urges the Office to implement the Court's recommendations in a timely manner, and in particular to:

- take comprehensive measures to rebuild the internal capacity and remedy the challenging human resources situation of the Office, which presents significant risks to the continuation of the Office's operations at the current scale;
- reinforce considerably the internal controls framework by establishing an internal audit capability within the Office, covering also support operations in other countries, as well as an internal legal service and systematic internal review of legal documents;

 strictly follow and respect the procurement procedures rules laid down in the Financial Regulation in order to ensure full compliance with the principles of competition, transparency, equal treatment and non-discrimination between tenderers;- deploy continuous efforts to address the serious deficiencies identified by the Court regarding the Office's payments for staff expenditure, for rent and related works, for travel expenditure and other payments.

Taking note of the Office's reply and the additional information provided, the Council welcomes the first positive steps undertaken by the Office, aimed at overcoming the irregularities found by the Court, especially the Office's Governance Action Plan, endorsed by the Management Board in September 2018. The Council calls on the Office to pursue rigorously the implementation of its corrective actions in line with the Court's recommendations, in order to achieve swift improvement in the areas of recruitment, internal controls and procurement.

The Council underlines the great importance it attaches to the follow-up of these corrective actions and calls on the Office, in the coming months, to inform the Council regularly and consistently of all progress made.

The Council regrets the Court's finding related to amendments to the specific grant agreements with the Institute's Knowledge and Innovation Communities (KICs), which goes against the purpose of encouraging KICs to find own resources of financing and become gradually financially independent from the Institute. The Council calls on the Institute to reduce the use of amendments to the specific grant agreements.

The Council welcomes the Institute's reinforcement of its internal control systems for grants to KICs by carrying out external checks on KICs' partners and providing certified financial statements (CFS) for KIC partners.

The Council takes note of the Court's observation that KICs did not fully use the grant amounts partly due to late approval of grant agreements, and partly due to a higher than planned self-financing of management costs by some KICs. While considering the higher amount of self-financing as a positive aspect, the Council calls on the Institute to strengthen its planning and procedures for approving the grant agreements.

Furthermore, the Council encourages the Institute to ensure proper transparency and publicity of its vacancy notices, while avoiding unjustified costs.

ECOMP.2.A www.parlament.gv.at The Council, whilst taking note of the Institute's reply and actions taken, regrets the weaknesses found by the Court in the Institute's procurement procedures and calls on the Institute to take appropriate actions in order to ensure the effectiveness of the process, competition in its procurement procedures, as well as the full implementation without unjustified delay of electronic public procurement.

As to filling some managerial positions on ad interim basis, the Council asks the Institute to fully comply with the Staff Regulations.
