I. INTRODUCTION

- 1. On 8 November 2018, the <u>European Court of Auditors</u> published Special Report No 30/2018 entitled "*EU passenger rights are comprehensive but passengers still need to fight for them*".
- 2. Pursuant to the rules set out in the Council conclusions on improving the examination of special reports drawn up by the European Court of Auditors¹, the <u>Permanent Representatives Committee</u> instructed on 28 November 2018 the <u>Working Party on Transport Intermodal Questions and Networks</u> to examine the report².

II. WORK AT THE PREPARATORY BODY

3. The <u>European Court of Auditors</u> presented its Special Report to the <u>Working Party on</u>

<u>Transport - Intermodal Questions and Networks</u> on 10 December 2018. The Working Party developed the draft Council conclusions in its meetings on 25 January, 8 February and 15 February 2019, and reached agreement on the text in Annex.

Draft Council conclusions

on

Special Report No 30/2018 by the European Court of Auditors

THE COUNCIL

- 1. TAKES NOTE of Special Report No 30/2018 by the European Court of Auditors on passenger rights.
- 2. AGREES on the importance of an appropriate level of protection for passengers using air, rail, waterborne and bus services in the Union and CONSIDERS that protecting these rights is a fundamental objective of Union transport policies.
- 3. REMARKS that the Special Report assesses the protection of passenger rights in those modes of transport where the Union has adopted legislation, namely in air, rail, waterborne and bus transport, taking into account the particularities of each transport mode.
- 4. NOTES that the Special Report finds the Union regulatory framework to be a unique solution world-wide.
- 5. As regards the application of the current legal framework, NOTES that the Special Report recommends that the Commission should issue guidelines to provide clarity, ACKNOWLEDGES the benefits of clear rules, but RECALLS that guidelines can provide only a voluntary framework and that they cannot prejudge or substitute Union legislation.
- 6. NOTES also that the Special Report encourages the Commission to take action to increase awareness on passenger rights, AGREES that the application of passenger rights is more efficient when all stakeholders are aware of their respective rights and obligations and therefore RECOGNISES the need for further organisation of information campaigns in this regard.

- 7. RECALLS that two legislative proposals are currently under negotiation, one on air passenger rights³ and another one on rail passenger rights⁴.
- 8. NOTES that certain recommendations by the European Court of Auditors touch upon key policy choices to be made in the said legislative discussion within and between the colegislators.
- 9. CONSIDERS that developing any positions on those recommendations at this stage could jeopardise the legislative process by prejudging it and, in any case, would substantially overlap with the work that still remains to be done.
- 10. Therefore RECOGNISES the work carried out by the European Court of Auditors as a relevant input to the ongoing legislative discussion.
