1. Die Kommission hat in der Sitzung der Gruppe "Telekommunikation und Informationsgesellschaft" vom 20. Februar 2019 einen Entwurf einer Erklärung für die dritte Ministertagung der Östlichen Partnerschaft über die digitale Wirtschaft, die am 28. Februar in Bukarest (Rumänien) stattfindet, vorgelegt.
2. Es ist geplant, dass die Erklärung am 28. Februar 2019 von Vertretern der Republik Armenien, der Republik Aserbaidschan, der Republik Belarus, Georgiens, der Republik Moldau und der Ukraine sowie von Vertretern der Europäischen Union und den Ministern und Vertretern ihrer Mitgliedstaaten angenommen wird.
3. Der Entwurf der Erklärung ist in der Anlage enthalten. Die Delegationen werden darauf aufmerksam gemacht, dass der Wortlaut des Entwurfs der Erklärung nicht endgültig ist und möglicherweise noch Anpassungen oder Änderungen, insbesondere in Bezug auf das Roaming, vorzunehmen sind.

4. Deshalb und in Anbetracht der Tatsache, dass die nächste Tagung des Rates am 4. März 2019 stattfindet, wird der Ausschuss der Ständigen Vertreter ersucht, er möge
- dem Rat empfehlen, die in der Anlage enthaltene Erklärung zu billigen und die Kommission zu ermächtigen, ihr im Namen der Union zuzustimmen, und
  - in Anbetracht der Dringlichkeit beschließen, für die vorgenannte Billigung und Ermächtigung das schriftliche Verfahren anzuwenden.

## **Third Eastern Partnership Ministerial Meeting on the Digital Economy**

**28<sup>th</sup> February 2019, Bucharest, Romania**

### **DECLARATION**

The Ministers responsible for the Digital Economy and the representatives of the Republic of Armenia, the Republic of Azerbaijan, the Republic of Belarus, Georgia, the Republic of Moldova and Ukraine, the representatives of the European Union and the Ministers and representatives of its Member States met in Bucharest, Romania, on 28<sup>th</sup> February 2019 to discuss the progress of the digital cooperation within the Eastern Partnership (EaP) framework and registered since the second Ministerial meeting in October 2017.

In this third Ministerial meeting and in view of the 10<sup>th</sup> anniversary of the Eastern Partnership due in May, the participants also addressed the challenges and opportunities of the digital economy in the EaP region. The participants reaffirmed the shared commitment to the digital economy, including the Harmonisation of Digital Markets (HDM) among the EaP partners and with the European Union.

Representatives of International Financial Institutions, regulatory authorities for electronic communications, research and education data networks, the EU4Digital project consortium, as well as representatives of the private sector and the civil society were also present.

Recalling the latest [Ministerial Declaration](#) of 5<sup>th</sup> October 2017 in Tallinn, which provided input to the [Joint Declaration of the 5<sup>th</sup> Eastern Partnership Summit](#) of 24<sup>th</sup> November 2017 in Brussels, the participants affirmed their commitment to deepen the cooperation in six joint priority topics (electronic communications and infrastructure, trust & security, eTrade, digital skills, ICT innovation & startup ecosystems and eHealth) and defined specific targets for 2020 as part of a roadmap for their digital cooperation, in the context of the 20 deliverables for 2020 and in order to ensure concrete benefits for citizens and businesses.

The participants have today adopted the following Declaration:

The participants reaffirm their commitment to the objectives stated in the Joint Staff Working Document "[Eastern Partnership - 20 Deliverables for 2020 - Focusing on key priorities and tangible results](#)" of June 2017, in particular regarding Deliverable no. 7: "Harmonisation of Digital Markets".

The participants welcome the launch by the European Commission, of [the first Eastern Partnership wide Action, under the EU4Digital brand](#), to support swift and effective implementation of reforms in the EaP partner countries for further developing the digital economy and society, in line with European Union norms, including legislation, standards and best practices.

EU4Digital will contribute to eliminate existing obstacles and barriers for pan-European online services for citizens, public administrations and businesses, including through the harmonisation of the digital environments, such as broadband infrastructure, among the EaP partners and with the European Union. The participants recognise that the effective implementation of these actions represents common interest for all parties and reaffirm their commitment to cooperate in order to maximise the impact stemming from action implementation.

International mobile roaming services play an important role in facilitating economic and social interactions, both for trade and travel. In this context, the participants welcome the progress made since 2017 and agree that reducing retail roaming charges increases the use of roaming services and contributes to increased citizens' welfare, choice and mobility.

In this context, the participants welcome the final results of the [study on "a harmonised approach to roaming pricing and reduced roaming tariffs among the EaP partners"](#), notably the options and measures proposed, while recognising the need for their update.

The EaP Ministers reaffirmed their commitment to sign by the end of 2020 a Regional Roaming Agreement, in order to reduce the roaming tariffs. To this aim, they adopted the joint roadmap for the six countries prepared by the Roaming Expert Working Group of their national regulatory authorities for electronic communications and endorsed by the HDM Panel on 7<sup>th</sup> February 2019. In this context, they reaffirmed their strong commitment to ensure all the internal procedures are completed by the agreed target dates.

The EU and EaP Ministers also agreed to explore the possibility of a common international roaming space, including towards the economically sustainable reduction of roaming tariffs between the EaP countries and the EU Member States. The participants agreed to launch discussions and to conduct a study to support that process - the study shall be launched in 2019 and be completed by the end of 2020.

The EU Ministers also encourage the Ministers of the EaP countries to align their priorities for spectrum coordination, including for 694-790 MHz ('700 MHz band') and 3.5 GHz, in order to free these bands for 5G deployment.

In the context of the 10<sup>th</sup> anniversary of the EaP and the ongoing reflection on the EaP agenda beyond 2020, the Ministers invite the HDM Panel to prepare and present by the autumn 2019 their suggestions on possible further objectives of EaP cooperation in the area of Digital Economy. These objectives shall also include their respective targets and milestones.

The EaP and EU Ministers invite the HDM Panel to continue monitoring and reviewing the progress of the cooperation on the Harmonisation of Digital Markets, as well as plans in this area and report as necessary to the corresponding EaP Multilateral Platform. They stand ready to meet again at Ministerial level to provide further political steering, including on emerging issues, to cooperation in this area.
