STATEMENTS TO THE LEGISLATIVE "B" ITEMS SET OUT IN DOC. 14795/18

<u>Ad "B" item 3</u>: **Regulation on establishing a European Labour Authority** *General approach*

STATEMENT BY BULGARIA

"Bulgaria supports the establishment of a European Labour Authority/Agency and the opportunity through its activities to facilitate access to information for workers, employers and national institutions on rights and obligations in the event of cross-border labour mobility situations; also supports the promotion of coordination between Member States in cross-border enforcement of the Union law. We believe that the establishment of a European Labour Authority/Agency will facilitate communication between Member States' authorities to resolve cross-border disputes between them and facilitate finding solutions in case of labour market disruptions.

However, we would like to express our concern regarding the inclusion of the road transport in the scope of the Regulation, namely: the legislative acts listed in Article 1, Paragraph 3 items g), h) and i).

We also would like to note that joint inspections in the field of road transport currently are carried out by the Bulgarian authorities in cooperation with other Member States within the framework of our membership in other European organizations, such as the Euro Contrôle Route (ECR).

In addition, we believe that the road transport legislation is specific and therefore is currently separated from the employment and social legislation.

We are also concerned about the legal uncertainty that would be created in connection to the discussions on the Mobility Package I, which are still ongoing after the general approach reached at the Transport, Telecommunication and Energy Council meeting on December 3rd 2018 and due to this reason the inclusion of the above legislative acts cannot be considered as a balanced text by definition."

<u>Ad "B" item 5</u>: **Directive on carcinogens or mutagens at work (third batch)** *General approach*

STATEMENT BY FRANCE, FINLAND, ITALY, LITHUANIA, THE NETHERLANDS, UNITED KINGDOM AND SLOVAKIA

"France, Finland, Italy, Lithuania, The Netherlands, United Kingdom and Slovakia support any measure which increases the safety and health of workers. It is in this spirit that France, Finland, Italy, Lithuania, The Netherlands, United Kingdom and Slovakia support the mandate of the Presidency on the revision of Directive 2004/37/EC.

However, France, Finland, Italy, Lithuania, The Netherlands, United Kingdom and Slovakia regret that the alternative option including complementary biomonitoring for cadmium compounds, as proposed by the Scientific Committee for limit values for occupational exposures (SCOEL) and the Advisory Committee for Occupational Safety and Health (ACSH), could not be retained in the general approach.

This alternative based on the use of biomonitoring provides the same degree of protection for workers through more precise controls of medical analysis while simplifying technical constraints for companies for those Member States wishing to apply it. This is why it should be better taken into account, where appropriate, in European legislation."

<u>Ad "B" item 6</u>: Recommendation on access to social protection for workers and selfemployed Political agreement

STATEMENT BY BULGARIA

"The Republic of Bulgaria appreciates the efforts of the Austrian Presidency and supports the objectives of the Recommendation to improve and broaden the scope of social protection for all employed persons, in particular for those working in atypical forms of work, and the self-employed persons.

However, the Republic of Bulgaria considers that the recommendation should take better account of the national characteristics of the social security systems of the Member States and, in this regard, wishes to reaffirm its concerns about the extension of the scope of formal coverage of the selfemployed persons, provided for in § 10 thereof, for occupational diseases and accident at work, even on a voluntary basis. This contradicts basic principles of the Bulgarian insurance model, where these risks are inherent only to the employees, which will lead to the impossibility for the country to fulfil this part of the recommendation in practice. The concerns are also related to the fact that, notwithstanding its non-binding nature, the Recommendation foresees the elaboration by each Member State, within 18 months of its adoption, of a plan for its implementation, which implementation will be monitored in the context of European Semester reporting.

For these reasons, in order not to block the adoption of the Recommendation, which implements basic principles of the European Pillar of Social Rights, the Republic of Bulgaria expresses its support for it but wishes to attach this statement to the minutes of the meeting of the Council, which confirms the incompatibility of the extension of the scope of social protection of the self-employed persons for accidents at work and occupational disease with the national insurance model."

STATEMENT BY SLOVAKIA

"The Slovak Republic supports the objectives of the recommendation, having in mind the changing realities of the world of work. The Slovak Republic reiterates that national situation of the Member States shall be taken into account, where the recommendation is to be implemented. Therefore, the Slovak Republic welcomes the increased flexibility of the text as well as non-binding nature of the recommendation.

Furthermore, the prerogatives of the Member States as regards the organisation of their social protection systems have to be respected. The Slovak Republic welcomes that the Recommendation recognizes the exclusive competence of the Member States with regard to the organisation of their social protection systems, including the level, substance and delivery of benefits, the level of contributions and the conditions for access.

The Slovak Republic recalls that according to Article 153(4) of the Treaty on Functioning of the EU the Union measures in the social policy field shall not affect the right of Member States to define the fundamental principles of their social security systems and must not significantly affect the financial equilibrium thereof.

The Slovak Republic still has concerns on paragraph 10 let. b) of the Recommendation. This provision recommends Member States *inter alia* to ensure access for self-employed persons, at least on voluntary basis, to accidents at work and occupational disease branch of their social protection system. The national system of the Slovak Republic provides for accidents at work and occupational disease insurance only for workers. This branch of social protection system is based on the principle of employer's liability for worker's accidents at work or occupational disease. The Slovak Republic deems this principle as a fundamental principle of the national social protection system.

In light of the previous text, the Slovak Republic considers the recommendation an instrument seeking to provide guidance for Member States when progressively adapting social protection systems in light of national circumstances."

STATEMENT BY THE NETHERLANDS

"The Netherlands supports the goals of the Council Recommendation to provide access to adequate social protection.

Taking into account article 153(4) TFEU which refers to the rights of Member States to define the fundamental principles of their social security systems, the government of the Netherlands interprets the recommendation as follows:

- Article 10 of the recommendation refers to national circumstances, which entails that Member States can make exceptions in light of these circumstances, for instance with regard to the application of the recommendation to workers and self-employed. This is in line with standard treaties of the International Labour Organization (ILO) and Council of Europe (ILO 102 and European Code of Social Security) in which groups can be excluded.
- Article 12 of the recommendation also refers to national circumstances, which entails that the elements of the article which are not applicable to the Dutch social protection system due to the fundamental distinction that is made between the level of protection needed for employees and self-employed, does not hinder the Netherlands in complying with the recommendation. The recommendation gives sufficient flexibility to take these country specific characteristics of social protection systems into account"

STATEMENT BY HUNGARY

"Having in mind that globalisation, technological developments and demographic changes create new challenges and opportunities in the labour market as well as in our welfare systems, Hungary supports the objectives of the Recommendation to provide access to adequate social protection to all workers in particular those in non-standard forms of employment and the self-employed. Hungary believes that the priority should be to empower our citizens for these changes, create more jobs and involve all persons capable to work into the labour market and in the same time avoid benefit dependency.

Hungary reminds that the implementation of the Recommendation should be in line with article 153 paragraph (4) TFEU which confirms that '*The provisions adopted pursuant to this Article: shall not affect the right of Member States to define the fundamental principles of their social security systems and must not significantly affect the financial equilibrium thereof, [...]'. Hungary underlines the principle of subsidiarity, the division of competences set out in the Treaties as well as differences between Member States' circumstances should also be taken into consideration.*

Hungary interprets the Paragraph 13 on adequacy as follows: ensuring adequate level of social protection should always take into account the Hungarian circumstances, national challenges and priorities as well as the entire set of provisions provided by the national social protection system. When considering these efforts budgetary implications should always be taken into account."
