4. Draft Council conclusions: enhancing safety of nuclear facilities and materials through a better physical protection

The Presidency provided the delegations with additional explanations on the opportunity to adopt Council conclusions on this topic and then opened the floor for comments.

The Presidency indicated that, for the next WP, a non-paper with background information should be distributed, with the aim of facilitating the discussion on the topic.

5. Draft Council conclusions: other uses of nuclear technologies than for electricity production

Before opening the floor for comments, the Presidency and the Commission introduced the topic using two PowerPoint presentations.

Delegations were invited to share three examples of good practices in the field by the end of April, with a view to compiling a booklet that the Presidency intends to distribute at Council meetings.

Any input to the brainstorming on the topic was encouraged.

The next Atomic Questions Working Party meeting will take place on **<u>8 March 2019</u>**.
