#### Whereas:

- (1) The Agreement on the European Economic Area<sup>1</sup> ('the EEA Agreement') entered into force on 1 January 1994.
- (2) Pursuant to Article 98 of the EEA Agreement, the EEA Joint Committee may decide to amend, *inter alia*, Annex II (Technical regulations, standards, testing and certification) and Annex XI (Electronic communication, audiovisual services and information society) to that Agreement.
- (3) Directive (EU) 2015/1535 of the European Parliament and of the Council<sup>2</sup> is to be incorporated into the EEA Agreement.
- (4) Annexes II and XI to the EEA Agreement should therefore be amended accordingly.
- (5) The position of the Union within the EEA Joint Committee should therefore be based on the attached draft decision,

# DECISION OF THE EEA JOINT COMMITTEE No .../2019

amending Annex II (Technical regulations, standards, testing and certification) and Annex XI (Electronic communication, audiovisual services and information society) to the EEA Agreement

THE EEA JOINT COMMITTEE,

Having regard to the Agreement on the European Economic Area ('the EEA Agreement'), and in particular Article 98 thereof,

Whereas:

- (1) Directive (EU) 2015/1535 of the European Parliament and of the Council of 9 September 2015 laying down a procedure for the provision of information in the field of technical regulations and of rules on Information Society services<sup>1</sup> is to be incorporated into the EEA Agreement.
- (2) Directive (EU) 2015/1535 repeals Directive 98/34/EC of the European Parliament and of the Council<sup>2</sup>, as amended by Directive 98/48/EC of the European Parliament and of the Council<sup>3</sup>, which is incorporated into the EEA Agreement and which is consequently to be repealed under the EEA Agreement.
- (3) While EFTA States can issue comments and detailed opinions with respect to a draft technical regulation notified by other EFTA States, they may only submit comments with respect to a draft technical regulation notified by the Member States of the Union and vice versa.
- (4) Annexes II and XI to the EEA Agreement should therefore be amended accordingly, HAS ADOPTED THIS DECISION:
