CONTEXT AND CONTENT OF THE PROPOSAL

- 1. The <u>Commission</u> submitted the above proposal to the Council on 14 November 2014.
- 2. The Agreement on maritime transport between the European Community and its Member States, of the one part, and the government of the People's Republic of China, of the other part¹ (the "Agreement") entered into force on 1 March 2008.
- 3. In accordance with Article 6(2) of the Act of Accession of Croatia, Croatia is to accede to the Agreement by way of a protocol between the Council and the People's Republic of China.

- 4. On 14 September 2012, the Commission was authorised by the Council to negotiate a Protocol amending the Agreement (the "Protocol") in order to take account of the accession of Croatia to the European Union.
- 5. The Protocol was initialled in Brussels on 20 June 2014.
- 6. On 2 March 2015, the Council adopted a decision authorising the signature of the Protocol.
- 7. The Protocol was signed in Brussels on 21 December 2018.

WORK WITHIN THE COUNCIL

- 8. The <u>Shipping Working Party</u> examined the proposal on 12 December 2014. Delegations made no comments on the proposal.
- 9. On 14 September 2015, the <u>Council</u> agreed in principle on the draft Council Decision, as revised by the legal-linguistic services, and decided to transmit it to the European Parliament for consent.
- 10. On 7 January 2019, the Council requested the consent of the European Parliament.

WORK WITHIN THE EUROPEAN PARLIAMENT

- 11. On 9 December 2014, the responsible Parliament committee, the <u>Committee for Transport</u> and <u>Tourism</u>, appointed Mr Francisco Assis (S&D-Portugal) as rapporteur.
- 12. On 12 March 2019, the Parliament decided to give its consent to the draft Council Decision.

CONCLUSION

13. The <u>Permanent Representatives Committee/Council</u> are invited to adopt the Decision as set out in documents 5083/15 and 5880/15, prepared by the legal-linguistic experts.
