THE COUNCIL OF THE EUROPEAN UNION,

Having regard to the Treaty on the Functioning of the European Union,

Having regard to Regulation (EU) 2019/128 of the European Parliament and of the Council of 16 January 2019 establishing the European Centre for the Development of Vocational Training (Cedefop)¹, and in particular Article 4 thereof,

Having regard to the lists of nominations for appointment submitted to the Council by the Governments of the Member States and by the employees' and the employers' organisations,

Whereas:

- (1) Regulation (EU) 2019/128 repealed and replaced Regulation (EEC) No 337/75 of the Council¹.
- (2) The members of the Governing Board established on the basis of Article 4 of Regulation (EEC) No 337/75 have remained in office and exercised the functions of the Management Board provided for in Article 5 of Regulation (EU) 2019/128 until the appointment of the members of the Management Board and of the independent expert in accordance with Article 4(1) of Regulation (EU) 2019/128.
- (3) The members and alternate members of the Management Board of the European Centre for the Development of Vocational Training should be appointed for a period of four years,

HAS ADOPTED THIS DECISION:
