### **EU/Member States Opening Statement**

Chairman,

I am speaking on behalf of the European Union and its Member States. We would like to thank the WIPO Secretariat for the preparation of the 22nd session of CDIP.

Chair, we are looking forward to working again under your leadership. We thank you and your Vice-Chairs for the work you have already conducted in preparation of this meeting.

In the week ahead of us we have to discuss a wide range of topics related with Intellectual Property and Development. We are looking forward to constructively engage ourselves in deliberations. We will listen carefully and with an open spirit to the interventions of other delegations.

The EU and its Member States take note of the comprehensive progress reports regarding several Development Agenda projects as well as on the implementation of the Development Agenda Recommendations. We especially appreciate the new and clear structure in the report concerning the Development Agenda recommendations which enables the recipient to navigate smoothly and get a quick overview.

Chairman,

On the outset let me thank the secretariat as well as all contributing delegations for the preparation of doc. CDIP/22/4 Rev.. In our view it provides a good overview and a good basis for our discussion.

While we have resolved already a number of recommendations, some outstanding issues are still open.

As already mentioned in the opening statement the EU and its Member States regret that the discussions in the last sessions did not result in a compromise on these recommendations.

While we continue to believe that recommendations 5 and 11 are already reflected in the overall activities of the Secretariat we do not want to repeat now our position in detail.

In general we may state that the impressive work done within WIPO to assist, help, and cooperate with MS, especially DCs, proved to be result-oriented and leading to tangible outcomes. This success is based on a reliable internal organization. We have to be very careful not to overload this organization with administrative tasks and burdens. This would simply bind resources which could be better used otherwise. Whenever we decide to assign WIPO a task we have to carefully weigh the amount of work and the costs against the expected results.

We believe the discussions should focus on the recommendations that have been agreed. We believe the most recent proposal from Group B, which aims to find a common approach between the submissions from Mexico and Peru offer a very good basis for our discussions.

With regard to the open questions we are prepared to listen carefully and with an open spirit to the arguments which may be raised by other delegations.

Mr. Chair, let me express our sincere hope that we will be able to solve the remaining issues in the current session of the CDIP.

Chair,

We thank the secretariat for the document CDIP/22/13.

We take note of the report regarding the contribution of the Intergovernmental Committee on Intellectual Property and Genetic Resources, Traditional Knowledge and Folklore (IGC) to the implementation of the respective Development Agenda. This report has been already presented to the General Assemblies.

The interventions of a number of delegations mention especially rec. 18 which urges the IGC to accelerate the process for protection of GRs, TK, and TCEs.

However, the work in the IGC proved to be very difficult. The IGC has worked hard to overcome existing differences of opinions between delegates.

We regret that up to now it was not possible to overcome these differences and to bridge the gap between the different positions.

While the CDIP is not the appropriate forum for dealing substantially with GRs, TK, and TCEs, we express our hope that the IGC may be able to make progress in the future.

CDIP/22/INF/2 Summary of the study on understanding the use of industrial design on Southeast Asian countries – the case of Indonesia, the Philippines and Thailand (take note)

Mr. Chair,

The EU and its Member States take note of the summary of the study on the use of industrial design in Indonesia, the Philippines and Thailand.

The study shows very interesting results especially that applicants dominantly are private and locally-owned companies being more than 21 years old and designers being between 35 and 50 years old or even older.

It was also interesting to learn that applicants assign considerable value to their design rights, with the median value between 30.000 to 100.000 USD, that there is a real risk of imitation and design innovation may be a way of breaking into foreign markets and increasing exports.

The study also revealed the need of potential issues for improvement, namely the fact that applicants perceive the application process long and difficult-to-understand.

Mr. Chair,

The EU and its Member States thank the Secretariat for document CDIP/22/INF/3 and take due note of the summary of the study on IP in the health sector innovation system in Poland.

It reveals some very interesting facts regarding the Polish industry and economy, for example, that generic medicines represent a considerable share of the polish market of medicines and the price of pharmaceuticals is among the lowest in Europe and although Poland has the largest medtech industry among CEE countries while there may be space for improvement regarding productivity.

It is also interesting that Polish health industry has innovated more than the national average. However, it is still far from EU levels and sale and licensing of exclusive rights are no popular form of commercialization.
