Please find attached a list received from the Commission services as 'early warning' on planned delegated acts.

The list has been transmitted in view of the election recess agreement between the Parliament, the Commission and the Council of October 2018 (doc. 11897/18), which provides:

• **under point III** that the Commission send to the EP and the Council a list of the delegated acts that it plans to adopt between 18 February and 23 August 2019. The same applies to the final draft Regulatory Procedure with Scrutiny (RPS) intended to be submitted to the committee vote during that period. The list of such planned acts is attached to this message. Part 1 covers planned RPS measures. Part 2 covers planned delegated acts.

• **under point II** a limited number of so-called special cases, in which the recess agreement does not apply. Such possible situations are included the attached list, under part 3. Should additional cases arise, the Commission is to immediately inform the EP and the Council.

As pointed out by the Commission, the list is of a purely indicative nature and is drawn up by the Commission for planning purposes. The Commission may therefore not pursue acts included in the list or it may adopt acts later than 23 August 2019.

The Commission may also need to adopt additional acts than those included in the list. This may notably be the case due to the uncertainties related to the ratification of the Withdrawal Agreement with the United Kingdom.
