Having regard to Regulation (EU) No 492/2011 of the European Parliament and of the Council of 5 April 2011 on freedom of movement for workers within the Union², and in particular Articles 23 and 24 thereof.

Whereas:

- (1) In its Decisions of 28 September 2018³, 15 October 2018⁴, 19 November 2018⁵ and 18 February 2019⁶, the Council appointed the members and alternate members of the Advisory Committee on Freedom of Movement for Workers for the period ending on 24 September 2020.
- (2) A seat as member in the employers' associations representatives category has fallen vacant as a result of the resignation of Ms Helo TAMME.
- (3) The Government of Estonia has submitted a nomination for the vacant seat,
