1. The General Secretariat of the Council has been informed of the resignation of Ms Aleksandra LANGE as alternate member of the above Committee in the government representatives category (for Poland).
2. Under Article 24 of Regulation (EU) No 492/2011 of the European Parliament and of the Council of 5 April 2011 on freedom of movement for workers within the Union, members and alternate members are appointed by the Council.

THE COUNCIL OF THE EUROPEAN UNION,

Having regard to Regulation (EU) No 492/2011 of the European Parliament and of the Council of 5 April 2011 on freedom of movement for workers within the Union², and in particular Articles 23 and 24 thereof.

Whereas:

- (1) In its Decisions of 28 September 2018³, 15 October 2018⁴, 19 November 2018⁵ and 18 February 2019⁶, the Council appointed the members and alternate members of the Advisory Committee on Freedom of Movement for Workers for the period ending on 24 September 2020.
- (2) A seat as alternate member in the government representatives category has fallen vacant as a result of the resignation of Ms Aleksandra LANGE.
- (3) The Government of Poland has submitted a nomination for the vacant seat,
