Having regard to the Treaty on the Functioning of the European Union,

Having regard to Council Decision of 16 January 2019 establishing the European Agency for Safety and Health at Work <sup>1</sup>, and in particular Article 4 thereof,

Having regard to the list of candidates submitted to the Council by the Governments of the Member States and by the employees' and the employers' organisations,
