Having regard to the Treaty on the Functioning of the European Union,

Having regard to Council Decision 2003/C 218/01 of 22 July 2003<sup>2</sup> on the setting up of an Advisory Committee on Safety and Health at Work, and in particular Article 3 thereof,

Whereas:

- (1) By its Decisions of 12 March 2019<sup>3</sup> and 15 April 2019<sup>4</sup>, the Council appointed the members and alternate members of the Advisory Committee on Safety and Health at Work for the period ending on 28 February 2019.
- (2) A seat as alternate member in the employers' representatives category has fallen vacant as a result of the resignation of Mr Pierre THILLAUD.
- (3) The government of France has nominated a candidate for the vacant seat,
