Having regard to Regulation (EU) 2019/126 of the European Parliament and of the Council establishing the European Agency for Safety and Health at Work (EU-OSHA), and repealing Council Regulation (EC) No 2062/94<sup>1</sup>, and in particular Article 4 thereof,

Whereas:

- (1) In its Decisions of 9 April 2019<sup>2</sup> the Council appointed the members and alternate members of the Management Board of the European Agency for Safety and Health at Work for the period from 1 April 2019 to 31 March 2023.
- (2) A seat as alternate member in the trade unions' representatives category has fallen vacant as a result of the resignation of Mr Eldwin BALZAN.
- (3) The trade unions' organisation ETUC has nominated a candidate for the vacant seat,
