Nomination of Mr Christian ILLEDITS, Landesrat, as member of the Committee of the Regions and Mr Hans-Peter DOSKOZIL, Landeshauptmann, as alternate member of the Committee of the Regions

Pursuant to Article 305 TFEU, the Council appoints members and alternate members of the CoR for five years on the basis of a proposal made by each Member State. Where the term of office of a member or an alternate member is terminated before expiry of that period, a replacement is appointed for the remaining term of office by the same procedure.

Mr Christian ILLEDITS, Landesrat, relinquished his position as President of the Burgenland Landtag (regional parliament) on 28 February 2019 and moved to the Burgenland regional government. It is necessary to re-nominate him on the basis of his new national political mandate.

The Austrian Federal Government accordingly decided, on 24 April 2019, to nominate Mr Christian ILLEDITS, Landesrat, as member of the Committee of the Regions.
