Statement by the Commission

"The Commission welcomes the efforts of the Member States to improve the coordination process prior to the meetings of the World Anti-Doping Agency.

Safeguarding the integrity of sport is one of the main priorities of the EU in the field of sport.

The Commission will continue to support Member States in these efforts, both at expert and political level.

However, the Commission would like to raise two issues with regard to "Annex II – Practical Arrangements regarding preparations for WADA meetings on matters falling within Union competences" proposed for adoption:

First, limiting the Treaty prerogatives of the institutions is against the law of the Union: the Commission is entrusted by Article 17 of the Treaty on the EU (TEU) with the prerogative to represent the Union, and this treaty prerogative cannot be limited by practical arrangements established unilaterally by the Council or by the Member States, as it is the case in Annex II – Practical arrangements regarding preparations for the WADA meetings on matters falling within EU competence.

Second, the on-the-spot coordination at the meetings of the World Anti-Doping Agency, or at other preparatory meetings, is to be convened and chaired by the Commission representative in the EU delegation, and not by the Presidency, as it is proposed in Annex II – Practical arrangements regarding preparations for the WADA meetings on matters falling within EU competence.

As Guardian of the Treaty, the Commission reserves all its rights."

Statement by the United Kingdom

"The United Kingdom (UK):

- Notes the intensive efforts by the Romanian Presidency, and preceding presidencies, to bring this file to a conclusion.
- Considers that the establishment of an interoperable architecture between EU information systems in the fields of police and judicial cooperation, asylum and migration to be a significant and necessary step towards greater European security. The UK remains strongly committed to our shared aim of a safer and more secure Europe for all our people. As such, the UK supported the Commission's interoperability proposal.
- Notes however that the text for adoption today falls short of that proposal's ambition in several key areas. It also differs significantly from the recommendations of the High Level Expert Group.
- Nonetheless, recognises that adoption of this file represents a step forward on important and shared priorities, and hopes that there is scope for the ambition of the original Commission proposal to be fully realised in the future."

Statement by France

"La France souscrit au Rapport annuel de l'Union européenne sur les droits de l'Homme et la démocratie dans le monde, qui rappelle le rôle moteur de l'Union européenne dans la promotion de principes au cœur de son identité et des enjeux de paix, de sécurité, de progrès et de développement au niveau mondial. La France souhaite apporter les précisions suivantes concernant les mentions aux droits des populations autochtones faites dans le rapport.

La France, attachée au principe d'égalité entre tous les individus, soutient toute démarche permettant d'assurer aux populations autochtones la pleine jouissance des droits fondamentaux.

Se référant à la déclaration interprétative qu'elle a formulée lors de l'adoption de la Déclaration des Nations-Unies sur les Droits des peuples autochtones, la France tient à rappeler qu'elle interprète les références, dans ce texte, aux «peuples autochtones» conformément à ses principes à valeur constitutionnelle d'indivisibilité de la République et d'unité du peuple français. La France ne reconnaît pas de peuples distincts au sein du peuple français, ni de droit collectif à quelque groupe que ce soit, défini par une communauté d'origine, de culture, de langue ou de croyance.

Les droits de l'Homme sont des droits universels qui ont vocation à s'appliquer à tous les individus, sans aucune distinction. La France reste engagée à ce que chaque individu puisse jouir pleinement et effectivement, sans aucune discrimination, de ces droits fondamentaux."

"In so far as the relevant amendments to Annex II to the International Convention for the Prevention of Pollution from Ships (MARPOL) and to the International Code on the Enhanced Programme of Inspections During Surveys of Bulk Carriers and Oil Tankers, 2011, amendments to the International Life-Saving Appliance Code, amendments to Forms C, E and P of the appendix to the International Convention for the Safety of Life at Sea, and to the International Code of Safety for Ships Using Gases or Other Low-flashpoint Fuels are concerned, their adoption at the IMO affects existing Union legislation. Therefore, these amendments fall within the exclusive external competence of the Union. Consequently, the Union position established in respect of those amendments cannot be limited in scope and must therefore be understood as covering them in their entirety, without prejudice to Article 2(2) TFEU."

"The Commission considers that the commitments to be undertaken by the Union at MSC 101, which would introduce amendments to the International Code of Safety for Ship Using Gases or Other Low-flashpoint Fuels (IGF Code), will affect common EU rules as laid down both in Directive 2009/45/EC on safety rules and standards for passenger ships and in Directive 2014/94/EU of the European Parliament and of the Council of 22 October 2014 on the deployment of alternative fuels infrastructure, or alter their scope. The Union position in respect of the amendments to the IGF Code must therefore be understood in the sense that the Union's exclusive competence results from the fact that both Directives 2009/45 and 2014/94 may be affected."

Statement by the Commission

"First, the Commission cannot agree with the undue limitation of the Union position for matters falling within shared Union competence, only to the extent that they affect common Union rules."

Second, the Commission cannot agree with the position of the Council that it would necessarily follow from the judgment of the Court of Justice in Joined Cases C-626/15 and C-659/16, that the Union can only support the establishment of Marine Protected Areas in the CCAMLR area together with its Member States, as it cannot be excluded that the establishment of such areas would affect existing EU rules or alter their scope.

In addition, the Commission cannot accept the hybrid nature of the decision of the Union with the representatives of the Governments of the Member States meeting within the Council.

The Commission therefore reserves its rights, including the right to avail itself of legal remedies, maintains its proposal and cannot support neither the addition of a new recital nor the amendment of Article 1 on the Proposal for a Council Decision concerning the position to be taken on behalf of the European Union in the Commission for the Conservation of Antarctic Marine Living Resources and repealing Decision 10840/14.

This decision cannot be accepted as constituting a precedent."

Statement by Germany

"German legal opinion for the running of ski courses as part of university courses

We maintain our interpretation of law that the running of ski courses by university teaching staff as part of university courses, insofar as these courses are not remunerated separately, do not represent a service within the meaning of Article 57 TFEU.

Reason: In this respect, no economic activity is being carried out, which is generally provided in exchange for remuneration. This legal opinion is rooted in the case law of the European Court of Justice, in which freedom to provide services does not apply for schools and universities at least not which belong to the public education system and which are wholly or partially financed from state funds (cf. Recital 34 of the EU Services Directive 2006/123/EC, which explicitly refers to this case law)."

Statement by Croatia

"The Republic of Croatia in principle supports the goals and objectives of this delegated regulation. However, Croatia considers that the current wording of this Regulation places unjustified barriers when it comes to the freedom to provide services.

Article 7(3), of this Regulation provides that the ski instructors who have obtained a qualification listed in Annex I in a Member State other than a signatory of the Memorandum at the moment of entry into force of this Regulation and are able to demonstrate professional experience of at least 200 days during the five years immediately preceding the entry into force of this Regulation shall benefit from the principle of automatic recognition as set out in Article 4(2).

Furthermore, Article 8(1) provides that the ski instructors who fall within the scope of this Regulation and have either successfully passed the Common Training Test or who enjoy acquired rights pursuant to Article 7, shall be issued a certificate of qualification. The certificate shall be issued by the Member State or by the competent authority in the Member State.

We consider that the requirement of 200 days of professional experience within the five years immediately prior to the entry into force of this Regulation is too excessive. Given the above, ski instructors would have to work at least 40 days a year, which is certainly a significant amount of time subject to variations in the length of ski seasons, especially given the fact that this is most often not a primary occupation. Therefore, the Republic of Croatia considers that the requirement in Article 7 of this Regulation should have been set to a maximum of 100 days, so that the ski instructors who have been engaged in this work for many years would be able to continue working without being deprived of already acquired rights."

Statement by Slovenia

"Slovenia would like to draw attention to the provision of Article 7.3 of the proposed delegated act. Slovenia believes that this provision concerning acquired rights is discriminatory towards the citizens of the signatories of the Memorandum of Understanding establishing a pilot project for a professional card to be issued to ski instructors in the Union ("Memorandum").

Slovenia believes that Article 7.3 provides certain rights for the citizens of Member States other than the signatories of the Memorandum, who will benefit from the principle of automatic recognition if they acquire the qualification form Annex I and attest that they have professional experience of at least 200 days during the five years preceding the entry into force of the delegated Regulation.

The same right is not provided for the citizens of the signatories to the Memorandum. For example, those Slovenian ski instructors who have not passed the Eurotest or Eurosecurity test, but have professional experience as ski instructors and have acquired national qualification for pursuing the profession will not have the right to automatic recognition of their professional qualification."

Joint statement from Belgium, France, Hungary, Luxembourg and Portugal

"Belgium, France, Hungary, Luxembourg and Portugal fully support the scientific grounds and the technical content of this delegated act.

However, we consider that:

1. It is essential to remain consistent with the legal basis provided by Framework Regulation (EEC) No 315/93 laying down Community procedures for contaminants in food and with the horizontal approach fostered since the Commission's 1997 Green Paper on the general principles of food law in the European Union.
2. Therefore, the new proposed maximum level for the contaminant erucic acid should be set in Commission Regulation (EC) No 1881/2006 setting maximum levels for certain contaminants in foodstuffs.
3. A transition period regarding the application of the new maximum limit for vitamin D in infant formulae should be granted.

We invite the European Commission to amend the relevant legal provisions, accordingly."
