5. ERA and Innovation Policy

5.1 Interim Evaluation of Horizon 2020 and preparations for the next Framework Programme for Research and Innovation

In its conclusions in 2015 and 2016, the Council invited ERAC to assess the coherence of partnership instruments for R&I. To this purpose, ERAC has decided to establish an ad-hoc Working Group. Delegates will agree upon the Chairperson, the mandate, the tasks and the timeline for the ad-hoc Working Group.

5.2 Update on ERA National Action Plans and strategies

The Commission will update Delegates on the preparations for the upcoming workshop on ERA National Action Plans, planned back-to-back to the ERAC plenary meeting on 15-16 March 2018 in Ploydiv.
