THE COUNCIL OF THE EUROPEAN UNION,

Having regard to the Treaty on the Functioning of the European Union,

Having regard to the Council Decision of 22 July 2003 setting up an Advisory Committee on Safety and Health at Work<sup>1</sup>, and in particular Article 3 thereof,

Having regard to the lists of nominations for appointment submitted to the Council by the Governments of the Member States.
