EXPLANATORY MEMORANDUM

1. CONTEXT OF THE DELEGATED ACT

The Estonian language version of Delegated Regulation (EU) 2017/654 contains several errors. In order to align the Estonian language version with the other language versions, a Delegated Regulation correcting Delegated Regulation (EU) 2017/654 needs to be adopted.

2. LEGAL ELEMENTS OF THE DELEGATED ACT

This Delegated Regulation corrects translation errors in the Estonian language version of Delegated Regulation (EU) 2017/654.

THE EUROPEAN COMMISSION,

Having regard to the Treaty on the Functioning of the European Union,

Having regard to Regulation (EU) 2016/1628 of the European Parliament and of the Council of 14 September 2016 on requirements relating to gaseous and particulate pollutant emission limits and type-approval for internal combustion engines for non-road mobile machinery, amending Regulations (EU) No 1024/2012 and (EU) No 167/2013, and amending and repealing Directive 97/68/EC⁽¹⁾, and in particular Article 24(11), Article 25(4)(a), (b) and (c), Article 26(6), Article 34(9), Article 42(4), Article 43(5) and Article 48 thereof,

Whereas:

- (1) The Estonian language version of Commission Delegated Regulation (EU) 2017/654⁽²⁾ contains several errors in Annexes I to VI that render those Annexes illegible.
- (2) The Estonian language version of Delegated Regulation (EU) 2017/654 should therefore be corrected accordingly. The other language versions are not affected,

HAS ADOPTED THIS REGULATION:

Article 1

Article 2

This Regulation shall enter into force on the twentieth day following that of its publication in the *Official Journal of the European Union*.
