Subject: **WRITTEN PROCEDURE:** COMMISSION DELEGATED REGULATION (EU) .../...of 13.12.2017 amending Delegated Regulation (EU) 2016/1675 supplementing Directive (EU) 2015/849 of the European Parliament and of the Council, as regards adding Sri Lanka, Trinidad and Tobago and Tunisia to the table in point I of the Annex in accordance with the procedure set out in Article 290 TFEU and with Article 9(2) of Directive 2015/849 of the European Parliament and of the Council
= Extension of the objection period

1. On 13 December 2017 the Commission notified to the Council the COMMISSION DELEGATED REGULATION (EU) .../...of 13.12.2017 amending Delegated Regulation (EU) 2016/1675 supplementing Directive (EU) 2015/849 of the European Parliament and of the Council, as regards adding Sri Lanka, Trinidad and Tobago and Tunisia to the table in point I of the Annex in accordance with the procedure set out in Article 290 TFEU and with Article 9(2) of Directive 2015/849 of the European Parliament and of the Council (doc. 15749/17).

2. The Council could object to this delegated act within a period of one month, i.e. until 13 January 2018.
 3. Considering that no Council meetings are scheduled before 22 January 2018 to take any decisions with regard to this delegated act, it is suggested - in agreement with the Presidency - to recur to a written procedure, pursuant to Article 12 of the Council's Rules of Procedure, to extend the objection period in accordance with Article 64(5) of Directive 2015/849 of the European Parliament and of the Council by one month, i.e. until 13 February 2018.
 4. Please state whether you agree:
 - to the use of the written procedure;
 - that the Council decides to extend the objection period by one month, i.e. until 13 February 2018 with regard to the above mentioned delegated act.
 5. Please answer "YES" or "NO" to each of the above two questions; you may also reply "ABSTAIN" to the second question.
 6. Any unilateral statements should be made separately.
