13. Priorities of incoming Finnish Presidency

The incoming Presidency presented its priorities for the CCWP for the second semester of 2019. The Presidency will focus on a) monitoring and facilitating the implementation of the 9th Action Plan; b) drafting the next 10th Action Plan; c) customs and CCWP contribution to internal security of the EU; d) developing the coordination mechanism of Joint Operations and e) revision of the JCO guide. Meetings are planned for the following dates: 8 July (plenary), 18 July (experts), 16 September morning (joint meeting LEWP/CCWP, 16 September afternoon (plenary), poss. 1 October (experts), 10 October (plenary), 4 November (joint meeting DUWP/CCWP tbc), 11 November (experts), 26 November (plenary), 4 December (experts), 17 December (plenary).
