#### d) Detailed grounds for the increase

The increase in commitment and payment appropriations is needed to cover the financial contributions as outlined in the three protocols implementing the Sustainable Fisheries Partnership Agreements between the EU and the Republic of Cape Verde (EUR 750 000), the Republic of Guinea Bissau (EUR 15 600 000) and the Republic of Gambia (EUR 550 000).

Following the conclusion of the negotiations as proposed by the Commission, the ratification procedure by both parties is ongoing:

- The Council adopted the decision on the signing of the protocol on the implementation of the Fisheries Partnership Agreement with the Republic of Cape Verde (8655/1/19 REV 1) on 16 May 2019 (OJ L 154, 12.6.2019, p. 1–2);
- The Council adopted the decision on the signing, on behalf of the European Union, and provisional application of the protocol on the implementation of the Fisheries Partnership Agreement between the EU and the Republic of Guinea-Bissau (8917/19) on 6 June 2019;
- The adoption of the Council decision on the signing, on behalf of the European Union, and provisional application of a Sustainable Fisheries Partnership Agreement between the European Union and the Republic of The Gambia and the Implementation Protocol is expected on 26 June 2019.
