Subject:	Council position on draft amending budget No 3 to the general budget for 2019 accompanying the proposal to mobilise the EU Solidarity Fund to provide assistance to Austria, Italy and Romania – <i>Adoption</i>

1. On 22 May 2019¹, the Commission submitted to the Council draft amending budget (DAB) No 3 to the general budget for 2019 regarding the mobilisation of the the EU Solidarity Fund for a total amount of EUR 293.5 million in commitment and payment appropriations.

The objective of this proposal is to finance the mobilisation of the EU Solidarity Fund to provide financial assistance to Austria, Italy and Romania in response to natural disasters that hit those countries in 2018.

The corresponding appropriations are to be recorded under Article 13 06 01 (*EU Solidarity Fund - Assistance to Member States in the event of a major natural disaster with serious repercussions on living conditions, the natural environment or the economy*).

2. The Budget Committee examined DAB No 3/2019 at its meeting on 24 May and was able to accept it without any changes.
3. At the close of its examination, the Budget Committee agreed to suggest that the Permanent Representatives Committee:
 - advises the Council to:
 - adopt the Council's position on DAB No 3/2019 as set out in point 2;
 - instruct the Presidency to prepare the budgetary documents to be sent to the European Parliament and to approve the draft letter in Annex 2 to that effect; and
 - have the Council's position published in the *Official Journal of the European Union* as set out in Annex 1.
 - agrees, by unanimity, to use the written procedure for this purpose.

COUNCIL DECISION

adopting the Council's position on draft amending budget No 3 of the European Union for the financial year 2019

THE COUNCIL OF THE EUROPEAN UNION,

Having regard to the Treaty on the Functioning of the European Union, and in particular Article 314 thereof, in conjunction with the Treaty establishing the European Atomic Energy Community, and in particular Article 106a thereof,

Having regard to Regulation (EU, Euratom) 2018/1046 of the European Parliament and of the Council of 18 July 2018 on the financial rules applicable to the general budget of the Union, amending Regulations (EU) No 1296/2013, (EU) No 1301/2013, (EU) No 1303/2013, (EU) No 1304/2013, (EU) No 1309/2013, (EU) No 1316/2013, (EU) No 223/2014, (EU) No 283/2014, and Decision No 541/2014/EU and repealing Regulation (EU, Euratom) No 966/2012¹, and in particular Article 44 thereof,

Whereas:

- the Union's budget for the financial year 2019 was definitively adopted on 12 December 2018²,
- on 22 May 2019, the Commission submitted a proposal containing draft amending budget No 3 to the general budget for the financial year 2019,
