On 10 July 2019, the Permanent Representatives Committee reached an agreement on the draft budget for 2020, on draft amending budgets (DAB) No 1, No 2, No 3 and No 4 to the general budget for 2019, on the information to national Parliaments in the context of DAB No 4/2019, on the mobilisation of the EU Solidarity Fund to provide assistance to Austria, Italy and Romania, on the adjustment of the amounts mobilised from the Flexibility Instrument for 2019, as well as on the use of the written procedure for their adoption by the Council.

Would you therefore please state whether you agree to:

- (1) confirm the agreement on the draft budget for 2020 and consequently:
  - adopt the Council's position on the draft general budget of the European Union for the financial year 2020 as recorded in documents 10919/19 + ADD 1 to ADD 5;
  - instruct the Presidency, assisted by the General Secretariat of the Council, to forward the Council's position together with the explanatory memorandum to the European Parliament, in accordance with Article 314(3) TFEU, and approve the letter set out in Annex III to document 10919/19 to that effect;
  - have the Council's position, as set out in Annex I to document 10919/19, published in the *Official Journal of the European Union*; and
  - record in the Council's minutes the statements recorded in Annex II to document 10919/19.
- (2) confirm the agreement on DAB No 1/2019 and consequently:
  - adopt the Council's position on DAB No 1/2019 as recorded in document 10923/19;
  - instruct the Presidency to prepare the budgetary documents to be sent to the
     European Parliament and approve the draft letter in Annex 2 to document 10923/19 to that effect; and
  - have the Council's position, as set out in Annex 1 to document 10923/19, published in the Official Journal of the European Union.

  - adopt the Council's position on DAB No 2/2019 as recorded in document 10924/19;
  - instruct the Presidency to prepare the budgetary documents to be sent to the
     European Parliament and approve the draft letter in Annex 2 to document 10924/19 to that effect; and
  - have the Council's position, as set out in Annex 1 to document 10924/19, published in the Official Journal of the European Union.
- (4) confirm the agreement on DAB No 3/2019 and consequently:
  - adopt the Council's position on DAB No 3/2019 as recorded in document 10925/19;
  - instruct the Presidency to prepare the budgetary documents to be sent to the
     European Parliament and approve the draft letter in Annex 2 to document 10925/19 to that effect; and
  - have the Council's position, as set out in Annex 1 to document 10925/19, published in the Official Journal of the European Union.
- (5) confirm the agreement on DAB No 4/2019 and consequently:
  - adopt the Council's position on DAB No 4/2019 as recorded in document 10988/19;
  - instruct the Presidency to prepare the budgetary documents to be sent to the
     European Parliament and approve the draft letter in Annex 2 to document 10988/19 to that effect;
  - have the Council's position, as set out in Annex 1 to document 10988/19, published in the *Official Journal of the European Union*;
