JOINT STATEMENT BY BULGARIA, CROATIA, CYPRUS, THE CZECH REPUBLIC, ESTONIA, FRANCE, GREECE, HUNGARY, IRELAND, ITALY, LATVIA, LITHUANIA, LUXEMBOURG, MALTA, POLAND, PORTUGAL, SLOVENIA, SLOVAKIA AND SPAIN

"As part of the contingency framework regarding the withdrawal of the United Kingdom from the EU, the solution related to the "rebates on the UK rebate" is a practical arrangement, strictly limited to the year 2019 only. This shall not constitute a precedent for 2020 or the future MFF 2021-2027."

STATEMENT BY THE COUNCIL AND THE COMMISSION

"The Council and the Commission confirm that the payments the United Kingdom will make under the Council Regulation, including the specific amount referred to in the third subparagraph of Article 2(1), shall be fully taken into account for future negotiations when calculating the outstanding obligations resulting from the United Kingdom's membership of the Union."
