## **NOTE VERBALE**

The Mission of Canada to the European Union presents its compliments to the Protocol Service of the European Commission and has the honour to request agrément of the European Commission and the Council of the European Union for the appointment of the new Head of Mission of Canada to the European Union, Mr. Bruce Baird Christie. Mr. Christie's curriculum vitae is attached.

We would like to ask that this request be subject to your accelerated procedure. Your normal procedure taking eight weeks will likely result in a reply during the formal writ period for federal elections to be held in Canada in the fall. The Government of Canada does not normally appoint ambassadors during an electoral campaign, so this could result in a lengthy delay, which would leave the Mission without an ambassador for several months. Given the high importance that Canada attaches to its relationship with the European Union, it is the strong preference of the Government of Canada to have an ambassador in place as soon as possible and especially this fall during an important period of transition for the leadership of European institutions.

The Mission of Canada to the European Union avails itself of this opportunity to renew to the European Union the assurances of its highest consideration.

Bruce Christie (BA Honours in Sociology and Political Science), Carleton University, 1984; MBA, University of Ottawa, 1990, joined the Department of Foreign Affairs and International Trade in 1990-. Since joining the Department he has held a number of senior positions in Ottawa and abroad. During his time at HQ, he was the Associate Assistant Deputy Minister in the Trade Policy and Negotiations Branch during which time he served as Canada's Chief Negotiator for the Comprehensive and Progressive Trans-Pacific Partnership Agreement (CPTPP), the Canada.Mercosur FTA negotiations, and the Canada-China FTA exploratory discussions from (2017-2019); Canada's Chief Air Negotiator and Director-General of the Intellectual Property, Services and Investment Trade Policy Bureau from (2014-2017); Director of the Regional Trade Policy Division from (2007-2009); Director of the Multilateral Trade Policy Division from (2004-2007); and held positions in the European Union, Japan, and Environment Divisions.

Positions overseas included as the Minister and Deputy Permanent Representative to the World Trade Organization at the Permanent Mission of Canada in Geneva from (2009-2014), during which he served as the Chairman of the WTO Committee on Government Procurement, and as Canada's lead negotiator in the Doha Round non-agricultural market access negotiations as well as on Russia's accession to the WTO. He was also posted to the Canadian Embassy in Sweden from (1998-2002) where he served as the Commercial Counsellor.
