The document gives details of progress made, contains drafting suggestions prepared by the Presidency and identifies the difficulties that still need to be addressed before the Council can reach a political agreement.

Full release to the public of the information contained in the document would affect the negotiating process and diminish the chances of the Council reaching an agreement.

Full disclosure of the document at this stage would therefore seriously undermine the decision making-process of the Council. As a consequence, the General Secretariat has to refuse full access to the document at this stage.²

Having examined the context in which the document was drafted and the current state of play on this matter, on balance the General Secretariat of the Council could not identify any evidence suggesting an overriding public interest in its full disclosure.

Having examined the context in which the documents were drafted and the current state of play, on balance the General Secretariat of the Council could not identify any evidence suggesting an overriding public interest in their disclosure.

We have also looked into the possibility of releasing parts of the documents.⁴ However, as the information contained in each of the documents forms an inseparable whole, the General Secretariat is unable to give partial access at this stage.

You can ask the Council to review this decision within 15 working days of receiving this reply (confirmatory application).⁵
