Having regard to the Treaty on the Functioning of the European Union,

Having regard to Council Decision 2003/C 218/01 of 22 July 2003² on the setting up of an Advisory Committee on Safety and Health at Work, and in particular Article 3 thereof,

Whereas:

- By its Decisions of 12 March 2019³ and 15 April 2019⁴, the Council appointed the members (1) and alternate members of the Advisory Committee on Safety and Health at Work for the period ending on 28 February 2019.
