**Subject: Proposal to change the members and alternate members of the

On 12 July 2019 the Ministry of Public Administration sent the Committee of the Regions its proposal to change the members and alternate members of the Slovenian delegation to the European Committee of the Regions for the period to 25 January 2020. On 26 September 2019 we were informed by the Committee that you are the competent authority for communicating this proposal to the General Secretariat of the European Commission [sic].

In accordance with Article 3(2) of the Rules of Procedure of the Committee of the Regions, the term of office of a member or alternate is terminated, inter alia, at the end of the electoral mandate on the basis of which they were appointed.

Regular local elections were held in Slovenia in November 2018, following which the mandates of five members or alternate members of the Committee ended.

The members of the Slovenian delegation to the Committee whose mandate has ended are:

In accordance with the criteria set out in the Decision on the criteria and procedure for the composition of delegations of representative associations of municipalities to international organisations of municipalities and other international organisations (Official Gazette of the Republic of Slovenia no. 14/11), we asked the representative associations of Slovenian municipalities to nominate suitable candidates to succeed the members or alternate members of the Slovenian delegation whose mandate has ended.
