Whereas:

- (1) In its Decision of 13 October 2015<sup>4</sup>, the Council appointed the members and alternate members of the Advisory Committee for the Coordination of Social Security Systems for the period ending on 19 October 2020.
- (2) A seat as member in the trade unions' representatives category has fallen vacant as a result of the resignation of Mr Stanisław RÓŻYCKI.
