EXPLANATORY MEMORANDUM

1. CONTEXT OF THE DELEGATED ACT

The Spanish language version of Delegated Regulation (EU) No 812/2013 contains two errors. In order to align the Spanish version with the other language versions, a Delegated Regulation correcting Delegated Regulation (EU) No 812/2013 needs to be adopted.

2. LEGAL ELEMENTS OF THE DELEGATED ACT

This Delegated Regulation corrects errors in the Spanish language version.

THE EUROPEAN COMMISSION,

Having regard to the Treaty on the Functioning of the European Union,

Having regard to Regulation (EU) 2017/1369 of the European Parliament and of the Council of 4 July 2017 setting a framework for energy labelling and repealing Directive 2010/30/EU¹, and in particular Article 16 thereof,

Whereas:

- (1) The Spanish language version of Commission Delegated Regulation (EU) No 812/2013² contains two errors in table 1, in cell row B and C of column M of Annex II as regards a difference in the formula of the thresholds for the M-size water heaters.
- (2) The Spanish language version of Delegated Regulation (EU) No 812/2013 should therefore be corrected accordingly. The other language versions are not affected,

HAS ADOPTED THIS REGULATION:

Article 1

Article 2

This Regulation shall enter into force on the twentieth day following that of its publication in the *Official Journal of the European Union*.
