Subject:	Governing Board of the European Centre for the Development of Vocational Training (CEDEFOP) Appointment of Mr Alex Hooshiar (DK) , member in the category of Employers' representatives

1. The General Secretariat of the Council has been informed by the Commission of the designation of Mr Alex HOOSHIAR (DK) in the category of representatives of Employers' organisations, replacing Mr Henrik Bach MORTENSEN.
2. Under Article 4 of Regulation (EEC) No 337/75, as amended by Regulation (EC) No 2051/2004, the members of the Governing Board, except for the Commission's representatives, are appointed by the Council for a period of three years.
3. The Permanent Representatives Committee could therefore suggest that the Council:
 - adopt the Decision annexed hereto as an "A" item on its agenda, and
 - request that it be published in the Official Journal of the European Union for information.

THE COUNCIL OF THE EUROPEAN UNION,

Having regard to Council Regulation (EEC) No 337/75 of 10 February 1975 establishing the European Centre for the Development of Vocational Training, and in particular Article 4 thereof ¹,

Having regard to the nominee submitted to the Council by the Commission as regards the Employers' representatives,

Whereas:

- (1) By its Decisions of 14 July 2015² and of 14 September 2015³, the Council appointed the members of the Governing Board of the European Centre for the Development of Vocational Training for the period from 18 September 2015 to 17 September 2018.
- (2) A member's seat on the Governing Board of the Centre in the category of representatives of Employers' organisations has become vacant for Denmark as a result of the resignation of Mr Henrik Bach MORTENSEN.
- (3) The members of the Governing Board of the aforementioned Centre should be appointed for the remainder of the current term of office, which expires on 17 September 2018.
