The SCA noted the presentation by the Commission on the technical aspects of the CAP Communication (with focus on the new delivery model) and the additional responses provided to delegations' questions. In addition, the SCA took note of the preliminary reactions of some delegations with a view to the next Council debate.

The SCA also took note of the Presidency's questions proposed in document ST 5241/18 and agreed to forward them to the Council for the exchange of views on 29 January.

7. **Organisation of future work**

The Presidency informed the SCA about the "Agriculture and Fisheries" Council on 29 January 2018, as well as the next SCA meeting on 5 February.

The Belgian delegation asked for an AOB item to be tabled at the next "Agriculture and Fisheries" Council meeting on 29 January, on the management of public stocks of skimmed milk powder.

The German and Czech delegations informed the SCA about their intention to request at Coreper, for that same "Agriculture and Fisheries" Council meeting, AOB items both related to the African swine fever issue.
