#### Statement by Hungary

"Hungary is fully committed to strengthening the cooperation with the African partners, especially in the field of migration challenges. However, Hungary wishes to highlight its national position concerning the declaration of the Sixth European Union-Africa Union Summit.

Hungary would like to emphasize that cooperation on migration between the two continents must be based on the respect for national competences. We wish to highlight that legal migration belongs to the national competence of states only. We do not believe that migration is an appropriate solution to address the demographic, economic and labor market challenges.

Accordingly, Hungary has consistently emphasized that instead of promoting, facilitating or managing migration, we have to stop this phenomenon. The focus should be on providing assistance to third countries locally by creating local conditions more conducive to stable growth and development, thereby allowing everybody to remain and live in their home countries in peace and prosperity.

Hungary is strongly committed to the fight against trafficking in human beings and smuggling and we support all initiatives and cooperation aimed at reducing and, ideally, eliminating the illegal activities of criminal organizations. Therefore, we believe that strengthening the border protection and border control through capacity building is of utmost importance.

We also need to clarify that migration is not a fundamental human right. We have to make a clear distinction between those in need of international protection and migrants who are only seeking better life conditions and clearly not entitled to any kind of international protection. Consequently, in our view, the general and automatic approach of designating all migrants as vulnerable is unacceptable.

Hungary would like to make it clear again, that instead of creating further pull-factors and exacerbating the current challenges, we should focus on real solutions: addressing the root causes of migration, fighting against human trafficking and smuggling, providing assistance to third countries and strengthening our cooperation on border protection."

#### Statement by the Commission

"The Commission can accept the Practical Arrangements, endorsed by COREPER on 27 April and established in response to recital 10 of the Council Decision (EU) 2022/451 of 3 March 2022 authorising the Commission to negotiate, on behalf of the Union, an international agreement on pandemic prevention, preparedness and response, as well as complementary amendments to the International Health Regulations (IHR) within the World Health Organisation (the "Council decision")<sup>[1]</sup>, subject to the understanding that they must be interpreted and applied in a manner consistent with the relevant provisions of the Treaties, and the relevant case-law of the Court of Justice.

In this regard, the Commission considers that, as Union negotiator (as per Article 17(1) TEU, Article 218(3) TFEU, and Article 1 of the Council decision), it will negotiate on behalf of the Union, and express Union positions in any meeting, body or forum related to the negotiation of the Pandemic Agreement and the IHR amendments on matters falling within Union competence, whether exclusive, shared or supporting, coordinating or supplementing (as set out in Articles 3, 4 and 6 of the TFEU).

The Commission further considers that, pursuant to Article 5(2) TEU, the Member States, or the Presidency of the Council on behalf of the Member States, if so authorised by the Member States, will express positions and negotiate only on matters falling within sole national competences, such as those set out in Article 168(7) TFEU. The Union and the Member States are bound by the principle of sincere cooperation (as per Article 4(3) TEU), and in particular "[t]he Member States shall facilitate the achievement of the Union's tasks and refrain from any measure which could jeopardise the attainment of the Union's objectives."

The Commission, as Union Negotiator, will regularly consult with the special committee designated by the Council (i.e. the Working Party on Public Health) in accordance with Article 218(4) of the TFEU and Article 2 of the Council decision. In this regard, the Union Negotiator, in accordance with the principle of sincere cooperation, will keep the special committee regularly informed throughout the negotiations of how these are progressing, and seek Member States' advice as appropriate. The special committee however is not called upon to establish negotiating positions of the Union, "a task which goes beyond the consultative function assigned to it" (see judgment of the Court (Grand Chamber) of 16 July 2015, C-425/13, European Commission v Council [Australia greenhouse gas emissions trading system], paragraphs 88-90). The Commission, as Union Negotiator, will furthermore keep regular contacts with the Member States' technical experts and representatives in Geneva with a view to consulting with them and seeking their advice, as appropriate (see recital 9 of the Council decision).

The Commission reserves all its rights on the matters indicated in this declaration."

### Joint statement by Bulgaria and Poland

"Bulgaria and Poland acknowledge the readiness of the Council Presidency to speak on behalf of the EU Member States on matters of national competence. This, in our view, would allow defending common positions also on issues, falling beyond the limited competence of the European Union in the area of cross-border pandemic prevention, preparedness and response.

As far as it is clear that this new international instrument – being it legally binding or not – has the potential to affect mostly the Member States' competences for the organisation and management of health services and medical care and the allocation of the resources assigned to them, Bulgaria and Poland, on the basis of and in accordance with the EU primary law, underline the need to respect national competences. This implies coordination of positions also beyond these areas of exclusive national competence, as stated in para 13. Undoubtedly, any common position, which concerns national competences, will require the consensus by the Member States, as rightly reflected in para 10.

With regard to the Union negotiator's mandate to negotiate on matters of Union competence, we refer to the substantive legal basis in Council Decision (EU) 2022/451 of 3 March 2022. We note in that context that the expression of any position by the European Commission should neither trigger any attempts for harmonization at EU level in areas of national competence, nor lead to any negotiation commitments by the Union, which *de facto* result in obligations for Member States as part of national responsibilities. For the sake of clarity, we note that the words "inextricably linked" in para 13 are not meant as wide interpretation of Union competences or as means to dilute the term "national competence".

Given the lack of clear catalogue, delineating matters where the Union negotiator will take a leading role alongside with Member States, we consider of paramount importance that each party negotiates within its competence. This will guarantee that Member States will be able to effectively defend their national positions and negotiate in the fields falling within their competences, while the European Union, within its limited role of Union negotiator, would take on the initiative only on matters, which do not exceed the scope of its own competences.

In full respect of the EU primary law, and in particular Art. 168 (7) TFEU and Art. 168 (5) *in fine*, for the avoidance of any doubt, Bulgaria and Poland confirm that on all matters of national competence, as full members of the World Health Organisation and in our national capacity, we will be defending our national position: being it by supporting the common position based on consensus, where this does not contradict the national positions, as well as in all cases, where a coordinated position was not agreed by consensus."
