#### Ukraine

#### Madam Chair,

- Thank you for giving me the floor. This statement is made by France, in its capacity as
   Presidency of the Council of the European Union, on behalf of the European Union and its 27
   Member States. The EU and its Member States support the statements delivered by Ukraine,
   Group B and CEBS.
- 2. At the outset let me express the EU and its Member States' full solidarity with Ukraine and the Ukrainian people. The EU condemns, in the strongest possible terms, Russia's unprovoked and unjustified military aggression against Ukraine, which grossly violates international law and the UN Charter, and undermines international security and stability.
- 3. The EU demands that Russia immediately cease its military actions, withdraw all its troops from the entire territory of Ukraine and fully respect Ukraine's territorial integrity, sovereignty and independence within its internationally recognised borders. Russia also needs to stop its disinformation campaign and cyber-attacks.
- 4. The EU strongly condemns the fact that, while discussing IP and development, IP institutional capacities in the protection of innovations and inventions, access to knowledge and technology, research and scientific institutions are put at stake by this aggression.

# Revised Project Proposal Submitted by Tunisia on Reducing Work-Related Accidents and Occupational Diseases through Innovation and Intellectual Property

(CDIP/28/4)

Chair,

- 1. The EU and its Member States would like to thank Tunisia for providing a revised project further to the last Committee discussion, contained in CDIP/28/4.
- We note with interest that the aim of the project is to help reducing work-related accidents and occupational diseases through innovation and intellectual property tools. We are interested in the project's impact on the improvement of working conditions, and especially interested in its targeting of the informal economy and in particular the counterfeit of tools, machinery and protective equipment.
- 3. We are also interested to note that the project aims at technology mapping and collaboration between the users and the creators of innovation.
- 4. We consider that targeting one or a few specific industry sectors, identified during the country studies, and developing awareness raising seminars to the companies of such sectors, and in particular of their Managers, could convey an additional impact to the project.
- 5. We would appreciate having detailed information on the WIPO Fellowships costs amounting to 234,300 CHF.

#### Strategy for future enhancement of WIPO Match

Madam Chair.

- 1. The EU and its Member States would like to thank the Secretariat for preparing the document on the 'Strategy for Future Enhancement of WIPO Match'.
- 2. The WIPO Match platform being the backbone platform to increase transparent exchange of information among the stakeholders in the IP ecosystem, to encourage cooperation amongst them, and to facilitate South-South, North-South and Triangular initiatives, we consider that an intuitive interface hosted on a modern user-friendly platform should achieve enhanced results.
- 3. We note that in addition to seeker-donor collaboration, the strategy mentions that the platform will include other mechanisms of cooperation, amongst which public-private partnerships. We would be interested in obtaining more information on how these partnerships will be presented on the platform, how the private entities will be selected to appear on the platform and whether this implies any financing from WIPO to private entities. (*Paragraph 17/III*)
