## **EXPLANATORY MEMORANDUM**

### **1. CONTEXT OF THE DELEGATED ACT**

The Danish language version of Delegated Regulation (EU) 2017/653 contains an error. In order to align that language version with the other language versions, a Delegated Regulation correcting Delegated Regulation (EU) 2017/653 needs to be adopted.

### **2. LEGAL ELEMENTS OF THE DELEGATED ACT**

This Delegated Regulation corrects a translation error in the Danish language version of the text.

THE EUROPEAN COMMISSION,

Having regard to the Treaty on the Functioning of the European Union,

Having regard to Regulation (EU) No 1286/2014 of the European Parliament and of the Council of 26 November 2014 on key information documents for packaged retail and insurance-based investment products (PRIIPs)<sup>1</sup>, and in particular Article 8(5) thereof,

Whereas:

- (1) The Danish language version of Commission Delegated Regulation (EU) 2017/653<sup>2</sup> contains an error in Part 1, point 4(c) of Annex II that alters the meaning of the provision.
- (2) The Danish language version of Delegated Regulation (EU) 2017/653 should therefore be corrected accordingly. The other language versions are not affected,

HAS ADOPTED THIS REGULATION:

## *Article 1*

## *Article 2*

This Regulation shall enter into force on the twentieth day following that of its publication in the *Official Journal of the European Union*.
